Collection of Personal Information

HBAN does not collect any personal data about you on this website, apart from information which you submit to HBAN such as:

In order to participate in questionnaires on the site we may require that you provide us with certain specific information, such your full name, email address, investment preferences or type of investments sought. Use of Personal Information

Any information which you provide in this way is not made available to any third parties, and is used by HBAN only in line with the purpose for which you provide it and in accordance with the Service provided by HBAN as set out in the Terms and Conditions *[[hyperlink to Terms and Conditions](#)]*.

Collection of Technical Information

This website does not use fixed “sessions” cookies. Cookies are small pieces of information, stored in simple text files, placed on your computer by a web site, which can be read by the website on your subsequent visits. The information stored in a cookie may relate to your browsing habits on the web page, or a unique Identification number so that the website can “remember” you on your return visit. Cookies do not contain personal information from which you can be identified, unless you have furnished such information to the website.

This website uses temporary “session” cookies which enable a visitor’s web browser to remember which pages on the website have already been visited. Visitors can use this website with no loss of functionality if cookies are disabled from the web browser.

Technical details in connection with visits to this website are logged by our internet service provider for our statistical purposes. No information is collected that could be used by us to identify website visitors. The technical details are logged are confined to the following terms:

- the IP address of the visitor’s web server. This is identifying details of your computer (or your internet company’s computer), expressed in “internet protocol” code (for example 192.168.72.34). Every computer connected to the web has a unique IP address, although the address may not be the same every time a connection is made.
- the top-level domain name used (for example .ie, .com, .org, .net).

- The previous website address from which the visitor reached us, including any search terms used.
- Clickstream data which shows the traffic of visitors around this website (for example pages accessed and documents downloaded).
- The type of web browser (the piece of software you use to red web pages such as Microsoft Internet Explorer or Netscape Navigator) used by the website visitor.

Use of Technical Information

HBAN will make no attempt to identify individual visitors, or to associate the technical details listed above with any third party (apart from our internet service provider, which records such data on our behalf and which is bound by confidentiality provisions in this regard), unless obliged to disclose such information by rule of law. Technical information will be used only by HBAN, and only for statistical and other administrative purposes.
